




A Look Into The Future Of Pill Counting

What is Optical Pill Verification (OPV)?

With the Optical Pill Verification software running on the Eyecon 9430, it will analyze the colored photos during the fill process to provide error detection based on size, shape, pill color and markings. It will alert the pharmacist or technician of a potential drug mismatch.





SAFETY:

The Eyecon features automatic, visual warnings which notify the operator when specific situations occur.

(X) WRONG FILL QUANTITY:

When completing an Rx in validation mode, if the displayed quantity does not match the prescription quantity, a display warning allows the operator to correct the fill amount. This prevents a common cause of fill errors when the operator counts the incorrect quantity.

DOUBLE-COUNT AND BACK-COUNT:

The Eyecon has the option to either double count your Rx fills and/or back-count the balance in your stock bottle after filling an Rx. Adjustments to the Eyecon can be based on the DEA classification level as compared to the DEA level specified in the Eyecon set up for each feature.



PARTIAL FILLS:

Eyecon tracks partially filled prescriptions so when either the correct or generic substitute inventory becomes available; the balance of the partially filled Rx can be filled. A display warning of the previous partial fill allows the operator to dispense the correct balance of the Rx. The Eyecon records every transaction including photos.



GENERIC SUBSTITUTIONS:

Allow the operator to dispense a generic equivalent to the b anded Drug Number sent to the Eyecon. A display warning allows the operator to accept or refuse the substitution. You also have the choice







>> CONNECTIVITY

The Eyecon has a built in Ethernet interface allowing connectivity on existing networks and beyond. This functionality means that not only can you connect to a range of Pharmacy Management Software (PMS) systems, but also allows you to use the Eyecon as part of your telepharmacy offering.

品 PMS INTEGRATION

Integration with the PMS means having a smoother workflow process while improving safety and security. Automating the data handling between the PMS and Eyecon means digitally recording every step of the Rx process including each verification process. Verification happens at every stage to ensure the correct Rx, Drug number, Stock bottle and quantity.

The Eyecon can also transfer a summary of all physical inventory counts to update perpetual counts quickly and accurately in an inventory management system.

☐ TELEPHARMACY

Eyecon seamlessly integrates with your existing telepharmacy solution by making it easy for remote verification of the Rx by recording HD images of the annotated tray image, color image of the pill tray, color image of the filled vial and a color image of the vial label. All images are associated with the Rx which include; date, time and dispensing user information.

AUDIT REPORTS

Audit reports allow staff to analyze various aspects of prescriptions filled by the Eyecon. The Eyecon allows you to search:

- C-II prescriptions;
- Specific Drug Numbers;
- Specific uses;
- Partial-fills;

The Eyecon is simple and easy to use which means your staff will need minimal training to have maximum benefits. This free's up pharmacy time and increases confidence and morale.



Scan Label - Scan barcode containing Drug Number, quantity, and Rx number. Or, with an interface, scan the existing barcode already on your vial label.



Scan Bottle - Scan barcode on stock bottle to validate that you've pulled the correct medication or be alerted to a generic substitution.



Verify - The Eyecon will proceed to count mode if the Rx label matches the stock bottle. The Eyecon will display an error if a mismatch is detected.



Count Pills - Pour pills onto tray until display turns green, indicating a match between required number of pills and number of pills on the tray.



Dispense - Press the Finish button to record the transaction. Then lift platter to slide pills into funnel.



Fill Vial - Use vial to lift funnel gate and allow pills to flow into vial.
